Regional fees from September 2016 to August 2017

Currency of payment

All IB World schools in IB Asia Pacific must pay in their assigned currency. The Singapore Dollar was introduced on 1st June 2014.

Application for candidacy fee

This non-refundable fee is charged once and is due prior to the submission deadline of 1st April before uploading the *Application for candidacy*. Late applications will be accepted before the second deadline of 1st October.

<p>Description and services</p> <p>For application for candidacy, interested schools are advised to submit applications as soon as possible. If school submits application for candidacy after the (a late fee is payable in addition to the application for candidacy. This fee covers the costs associated with processing the late application to be considered for the current round of application for candidacy, at the discretion of IB.</p>	

Annual Candidate fee

The annual candidate fee is charged to the school for every year of candidacy until the school is authorised. The period between being accepted as a candidate school by the IB Organization (on the basis of Application for candidacy) and requesting authorization (on the basis of Application for authorization) can vary widely—it is at least one year and often two or up to three years.

Description and services

The *Annual candidate fee* is payable by DP / MYP / PYP candidate schools, for each year during which a school retains candidate status (every 1st September or every 1st of March).

If a school desires to terminate their IB candidate status the IB is must receive a formal letter, signed by the Head of School in this regard. This should be a minimum of 3 months before the termination of the billing year.

This fee covers the costs associated with :

- access to the Online Curriculum Center (OCC), coordinator notes, programme development and updates
- advice either through the regional office or from IB approved consultants
- a two-day on-site consultation visit including associated travel and incidental costs
- 20 hours of remote consultancy per candidate year
- the review and processing of the *Application for authorization* and supporting documentation
- two-day on-site verification visit including associated travel and incidental costs
- work associated with the visits (organisation, monitoring and follow-up)
- processing of the report

The fee is exclusive of accommodation required when visiting a school, which is booked and paid for by the visited school.

CP 1 Candidate fee

The CP 1 *candidate fee* (formerly known as IBCC) for DP and Continuum schools only, is charged to the school prior to acceptance of candidacy and is valid until school authorization.

This fee covers the costs associated with:

- access to curriculum materials and updates
- advice either through the regional office or from IB approved consultants
- 10 hours of remote consultancy
- the review and processing of the *Application for authorization* and supporting documentation
- one-day on-site verification visit including associated travel and incidental costs
- work associated with the visits (organisation, monitoring and follow-up)
- processing of the report

The fee is exclusive of accommodation required when visiting a school, which is booked and paid for by the visited school.

CP 2 Application and Candidate fee

The non-refundable Application fee is charged once and is due prior to the submission deadline of 1st April before uploading the *Application for candidacy*. Late applications will be accepted before the second deadline of 1st October.

The CP 2 candidate fee is charged to the school prior to acceptance of candidacy and is valid until school authorization.

Description and services

The Application Fee covers the costs associated with:

- the review and processing of the Application for candidacy
- advice and guidance in relation to programme implementation

The Annual Candidate Fee covers the costs associated with:

- the review and processing of the *Application for authorization* and supporting documentation

The fee is exclusive of accommodation required when visiting a school, which is booked and paid for by the visited school.

Evaluation Visit fee

Programme evaluation is both a requirement and a service provided by the IB Organization to IB World Schools. The aim is for the IB to ensure on a regular basis that the standards and practices of the programme are being maintained.

Description and services

This fee covers the costs associated with :

- Reading of self-study and supporting documents by external readers
- associated travel of 2-3 visitors per programme
- incidental costs of visiting team

These costs were previously charged to schools after the visit. Following the evaluation visit, there will be no recharges to schools unless exceptional circumstances occur.

This fee does not cover accommodation required when visiting a school, which is booked and paid for separately by the visited school. The accommodation booked and paid by the visited school should include breakfast and internet connection. For the DP, this fee is only applicable if an evaluation visit is organized.

Annual school fee

IB World Schools pay an 'annual school fee' for each programme they are authorized to teach.

However, if a school offers a combination of the Primary Years Programme (PYP), the Middle Years Programme (MYP) and the Diploma Programme (DP) - or offers all three - that school pays a reduced fee, to reflect their commitment to the IB.

The discount a school receives depends on the number of programmes they offer. If a school offers two programmes from the above list, the school is given a 10% discount on the lowest single programme fee they would otherwise pay; if the school teaches all three programmes listed above, the discount is 10% on the combined cost of the two lowest programme fees.
